This IL provides industry notifi	cation of the impending split	of the 919 NPA.		

We have been advised by BollSouth Telecommunications that substantial telephone number growth in the central North Carolina area necessitates splitting the existing 919 NPA (area code) and the simultaneous introduction of a new 910 NPA. Both NPAs will have interchangeable central office codes (i.e., the second digit of a central office code may be any digit 0-9).

The new 910 NPA will lactude the Greensboro, Fayetteville, and Wilmington LATAs, while the Raleigh and Rocky Mount LATAs will remain in the 919 NPA.

The split of the 919 NPA is scheduled for 2:00 AM Eastern Standard Time, Sunday, November 14, 1993. There will be a permissive dialing period starting at 2:00 AM Eastern Standard Time, Sunday, November 14, 1993 and ending at 2:00 AM Eastern Standard Time, Sunday, February 11, 1994. During the permissive dialing period either 919 or 910 will be acceptable in a dialed number terminating in the new NPA. After the permissive period, calls dialed with incorrect NPA codes, as defined in the NPA split information published in the Local Exchange Routing Guide (LERG), will be routed to intercept. Changes in the local exchange routing information, based on data provided by BellSouth Telecommunications, will be incorporated into the LERG and the NPA NXX Activity Guide (NNAG) and will be available May 1, 1993.

The dates that switching systems in the new 910 NPA will begin transmitting "910" in the calling number Automatic Number Identification (ANI) will be coordinated by BellSouth Telecommunications with the interestchange carriers.

Test calls to verify routing to the new NPA can be made by calling 910-574-3610. This test number will become available on October 15, 1993, and remain operational for a minimum of 30 days after the end of the permissive period.

The attached map illustrates the 919 and 910 configuration after the split. A listing of the communities to be served by each area code after the split is also included,

The dialing plan for the new 910 and 919 NPAs will be the same:

- All home NPA (HNPA) "local" calls will be dialed on a 7 digit basis with no prefix; i.o., NXX + XXXX
  (7 digits).
- All home NPA (HNPA) direct dialed "toll" calls must be dialed with a prefix "1" and 10 digits; i.e., I + IINPA + NXX + XXXX (1 + 10 digits).
- All foreign NPA (FNPA) direct dialed toll calls must be dialed with a prefix "1" and 10 digits; i.e., 1 +
  FNPA + NXX + XXXX (1 + 10 digits).
- Operator assisted calls including credit card calls, collect, and third party calls can be dialed with either a
  "0" or a "10XXX + 0" prefix and 10 digits; i.e., 0 + NPA + NXX + XXXX; or 10XXX + 0 + NPA +
  NXX + XXXX.


