Subject: Extraordinary NPA-Specific Jeopardy Conservation Procedures Announced for North Carolina and

South Carolina Numbering Plan Areas

We have been notified by BellSouth Telecommunications, the administrator for North Carolina and South Carolina, that because number demand has increased beyond normal forecasts, the following four NPAs are in jeopardy of exhausting prior to when relief can be provided: NPAs 704, 910 and 919 in North Carolina and NPA 803 in South Carolina. According to the Central Office Code (NXX) Assignment Guidelines (document INC 95-0407-008), "A jeopardy condition exists when the forecasted and/or actual demand for NXX resources will exceed the known supply during the planning/implementation interval for relief." The purpose of this notice is to announce that extraordinary NPA-specific conservation measures as defined in Section 8.5 of the guidelines have become necessary for the above NPAs.

BellSouth has provided NANPA information about extraordinary NPA-specific conservation procedures that have become effective for each of the above listed NPAs, as shown on the Attachments. These procedures have received industry consensus and are being implemented to insure the remaining NXX codes in each NPA best meet the industry and community needs until relief can be provided.

- 1. Except as provided below, a maximum of <u>seven NXX</u> codes will be assigned each month, no more than one per service provider, for the months of August and September, 1997. Code assignments after September, 1997 will be in accordance with procedures developed by the industry after the North Carolina Utilities Commission releases an NPA Relief Order.
- 2. Code requests should be submitted to the central office code administrator, Millie Cook, via facsimile on 404-524-2918 no sooner than 9:00 AM Eastern Time on August 19, 1997, and, no sooner than 9:00 AM Eastern Time on September 9, 1997.
- 3. If more than <u>seven</u> codes are requested during a month, codes will be assigned on a first come first served basis for the first <u>seven</u> requests received; and, the remaining requests will be returned to the applicants advising that the requests should be resubmitted the following month.
- 4. A service provider may receive no more than one code each month. However, if less than seven service providers request a code assignment by August 26th, or by September 16th, additional NXX codes may be assigned in that month, on a first come first served basis, to those service providers who need additional numbering resources to meet their business needs.
- 5. If less than <u>seven</u> codes are assigned during a month, the difference between <u>seven</u> and the number of codes assigned will be added to the <u>seven</u> codes available for assignment the following month.
- 6. Requests for codes from a future month's allocation of <u>seven</u> codes will not be accepted in advance of 9:00 AM ET on the ninth calendar day of that month.
- 7. These extraordinary jeopardy NXX assignment procedures are effective on August 12, 1997, and will continue until they are modified or until NPA relief is provided. Central Office code requests received after February 16, 1998 will be assigned from the new area code.
- 8. No code reservations or expedited activations will be allowed during the jeopardy period. In addition, per Section 8.4.D of the Guidelines, holders of reserved codes are being asked to voluntarily return their codes or confirm their planned activation dates.

The code exhaust situation will be re-examined after receipt of an NPA Relief Order, and these jeopardy procedures may be amended, if necessary.

ADOPTED BY INDUSTRY CONSENSUS ON AUGUST 12, 1997.

- 1. Except as provided below, a maximum of <u>five NXX</u> codes will be assigned each month, no more than one per service provider, for the months of August and September, 1997. Code assignments after September, 1997 will be in accordance with procedures developed by the industry after the North Carolina Utilities Commission releases an NPA Relief Order.
- 2. Code requests should be submitted to the central office code administrator, Millie Cook, via facsimile on 404-524-2918 no sooner than 9:00 AM Eastern Time on August 21, 1997, and, no sooner than 9:00 AM Eastern Time on September 10, 1997.
- 3. If more than <u>five</u> codes are requested during a month, codes will be assigned on a first come first served basis for the first <u>five</u> requests received; and, the remaining requests will be returned to the applicants advising that the requests should be resubmitted the following month.
- 4. A service provider may receive no more than one code each month. However, if less than <u>five</u> service providers request a code assignment by August 28th, or by September 17th, additional NXX codes may be assigned in that month, on a first come first served basis, to those service providers who need additional numbering resources to meet their business needs.
- 5. If less than <u>five</u> codes are assigned during a month, the difference between <u>five</u> and the number of codes assigned will be added to the <u>five</u> codes available for assignment the following month.
- 6. Requests for codes from a future month's allocation of <u>five</u> codes will not be accepted in advance of 9:00 AM ET on the tenth calendar day of that month.
- 7. These extraordinary jeopardy NXX assignment procedures are effective on August 12, 1997, and will continue until they are modified or until NPA relief is provided. Central Office code requests received after February 16, 1998 will be assigned from the new area code.
- 8. No code reservations or expedited activations will be allowed during the jeopardy period. In addition, per Section 8.4.D of the Guidelines, holders of reserved codes are being asked to voluntarily return their codes or confirm their planned activation dates.

The code exhaust situation will be re-examined after receipt of an NPA Relief Order, and these jeopardy procedures may be amended, if necessary.

ADOPTED BY INDUSTRY CONSENSUS ON AUGUST 12, 1997.

- 1. Except as provided below, a maximum of <u>twelve</u> NXX codes will be assigned each month, no more than one per service provider, for the months of August and September, 1997. Code assignments after September, 1997 will be in accordance with procedures developed by the industry after the North Carolina Utilities Commission releases an NPA Relief Order.
- 2. Code requests should be submitted to the central office code administrator, Millie Cook, via facsimile on 404-524-2918 anytime in August until twelve codes have been assigned; and, for September, 1997, no sooner than 9:00 AM Eastern Time on September 11th.
- 3. If more than <u>twelve</u> codes are requested during a month, codes will be assigned on a first come first served basis for the first <u>twelve</u> requests received; and, the remaining requests will be returned to the applicants advising that the requests should be resubmitted the following month.
- 4. A service provider may receive no more than one code each month. However, if less than twelve service providers request a code assignment by August 28th, or by September 18th, additional NXX codes may be assigned in that month, on a first come first served basis, to those service providers who need additional numbering resources to meet their business needs.
- 5. If less than <u>twelve</u> codes are assigned during a month, the difference between <u>twelve</u> and the number of codes assigned will be added to the <u>twelve</u> codes available for assignment the following month.
- 6. Requests for codes from a future month's allocation of <u>twelve</u> codes will not be accepted in advance of 9:00 AM ET on the eleventh calendar day of that month.
- 7. These extraordinary jeopardy NXX assignment procedures are effective on August 12, 1997, and will continue until they are modified or until NPA relief is provided. Central Office code requests received after April 24, 1998 will be assigned from the new area code.
- 8. No code reservations or expedited activations will be allowed during the jeopardy period. In addition, per Section 8.4.D of the Guidelines, holders of reserved codes are being asked to voluntarily return their codes or confirm their planned activation dates.

The code exhaust situation will be re-examined after receipt of an NPA Relief Order, and these jeopardy procedures may be amended, if necessary.

ADOPTED BY INDUSTRY CONSENSUS ON AUGUST 12, 1997.

- 1. Except as provided below, a maximum of six NXX codes will be assigned each month, no more than one per service provider, from September, 1997 through July, 1998.
- 2. Code requests should be submitted to the central office code administrator, Millie Cook, via facsimile on 404-524-2918 no sooner than 9:00 AM Eastern Time on the sixth calendar day of the month. Note: For the months of September and December it will be the 5th calendar day of the month, i.e. 9/5, 10/6, 11/6, 12/5, 1/6, 2/6, etc.
- 3. If more than <u>six</u> codes are requested during a month, codes will be assigned on a first come first served basis for the first <u>six</u> requests received; and, the remaining requests will be returned to the applicants advising that the requests should be resubmitted the following month.
- 4. A service provider may receive no more than one code each month. However, if less than <u>six</u> service providers request a code assignment by the 15<sup>th</sup> of the month, (9/15, 10/15, 11/14, 12/15, 1/15, 2/13, etc., additional NXX codes may be assigned in that month, on a first come first served basis, to those service providers who need additional numbering resources to meet their business needs.
- 5. If less than <u>six</u> codes are assigned during a month, the difference between <u>six</u> and the number of codes assigned will be added to the <u>six</u> codes available for assignment the following month.
- 6. Requests for codes from a future month's allocation of six codes will not be accepted in advance of 9:00 AM ET on the sixth calendar day of that month. Note: For the months of September and December it will be the 5th calendar day of the month, i.e. 9/5, 10/6, 11/6, 12/5, 1/6, 2/6, etc.
- 7. These extraordinary jeopardy NXX assignment procedures are effective on August 21, 1997, and will continue until they are modified or until NPA relief is provided. Central Office code requests received after August 1, 1998 will be assigned from the new area code.
- 8. No code reservations or expedited activations will be allowed during the jeopardy period. In addition, per Section 8.4.D of the Guidelines, holders of reserved codes are being asked to voluntarily return their codes or confirm their planned activation dates.

In mid-October, 1997, the code exhaust situation will be re-examined and these jeopardy procedures may be amended, if necessary.
