Subject: NPA 331 to Overlay NPA 630 (Illinois)

Related Previous Planning Letters: PL-195, PL-357

General Description

On June 30, 1999 the Illinois Commerce Commission (ICC) in Docket No. 98-0847, approved an all-services distributed overlay as the relief method for the 630 NPA. The 630 NPA serves a portion of northern Illinois, including cities and communities such as Aurora, Elburn, Kaneville, Lemont, Lisle, Naperville, Plano, Roselle, St. Charles, West Chicago, Wheaton and Yorkville. The new 331 NPA will serve the same geographic area currently served by the existing 630 NPA.

Implementation of Relief Plan

Implementation of the overlay of the 331 NPA is as follows:

The unique implementation intervals provided by the Commission required all NXX codes to be assigned from the 630 NPA before assignments could be made from the 331 NPA. The last available 630 NPA-NXX code was assigned on June 27, 2007. On March 16, 2007, NANPA notified the ICC regarding the status of the 630 NPA with only two remaining codes available for assignment to comply with at least a thirty-day notice prior to the assignment of the first code from the 331 NPA. On July 6, 2007, NANPA notified the ICC that the first code was assigned from the new 331 NPA. This date serves as the start of a ninety-day permissive dialing period and allows service providers to notice their customers.

During the permissive dialing period, subscribers may dial local calls within the overlay area on either a 7-digit or 1 plus 10-digit basis, but will be encouraged to dial 1 plus 10-digits. After the permissive period ends, all calls must be dialed using 1 plus 10-digits.

When preparing for overlay area code relief, carriers are strongly encouraged to prepare their switches to begin sending 10 digits prior to the mandatory 1 plus 10-digit dialing conversion date for customers.

Central Office Code Listings and NPA Map

Maps of the 630/331 NPA overlay are attached. Dialing Plan

Coincident with the introduction of mandatory 1 plus 10-digit dialing, the dialing plan for the 630 and 331 NPAs will be as follows:

Network Testing

All international and domestic carriers should ensure that the new 331 NPA has been activated throughout their networks. The test number to verify the routing to the new 331 NPA is 331-330-0331 and will be available until November 6, 2007. A recorded announcement will indicate that the test call has been successfully completed.

The information in this planning letter reflects detailed information about NPA relief activities. The information has been derived from commission orders and from industry implementation decisions. The implementation of the plan described in this letter is the responsibility of individual service providers, and NANPA does not guarantee that the activities and plans will occur exactly as described herein.
